JUDGMENT

This cause came to be heard on the 3rd day of February, 2025 in Lafayette Parish, Louisiana Temporary Restraining Orders and Injunctive Relief under La. C.C.P. Article 3601 before Honorable Judge Cynthia Spadoni on the Petitions for Protection from Abuse filed by Petitioner Cougar Goodbear against Chari Bush Rubin, Ashley Bush White, and Alfreda Mathieu.

Appearing were Cougar Goodbear; Christine Mire, attorney for Cougar Goodbear; Chari Bush Rubin, Ashley Bush White, and Alfreda Mathieu; and Jonathan T. Jarrett, counsel for the Defendants. The Court, having heard the testimony and evidence of the parties, ruled as follows:

IT IS ORDERED, ADJUDGED AND DECREED that the Petitions for Protection from

Abuse filed by Cougar Goodbear against Chari Bush Rubin and Alfreda Mathieu are dismissed

with prejudice;

DECREED that the Preliminary Injuctions filed by Cougar Goodbear against Alfreda Mathieu

and Chari Bush Rubin are denied.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a Preliminary under La. C.C.P. 3601 Injunction is hereby issued in favor of Cougar Goodbear and against Ashley Bush White, prohibiting Ashley Bush White from having any physical contact with Cougar Goodbear, and prohibiting Ashley Bush White from communicating with Cougar Goodbear, including any communication through a third party and through social media;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Preliminary Injunction shall remain in full force and effect for twelve months, until February 3, 2026.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Court Costs for the Petitions for Protection from Abuse against Alfreda Mathieu and Chari Bush Rubin are cast against Cougar Goodbear;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Court Costs for the Petition for Protection from Abuse against Ashley Bush White are cast against Ashley Bush White.
